### **School Consolidation Update**

The mayor spoke at length about the history of the LBI school.

Of note:

- School has always been zoned as Public Land.
- Judge invalidated Ordinance 2021- 05 because the adoption procedure was not in accordance with Municipal Land Use Law it should have only gone through the Land Use Board (Town Council should not have been involved)
- Master plan needs updating to include a housing element addressing the town's affordable housing obligation.
- Several problems with LBI school
  - East wing pilings were rotting above ground, this was fixed, but West wing was never addressed
  - Heating unit in the basement was flooded during Sandy it was repaired, but not replaced
- If Pagnotta wants to build 24 homes, needs to:
  - $\circ$  Obtain a use variance from the Land Use Board and an approved major subdivision.
  - Consider the current value of the land
  - Consider cost of a water tower (increased demand)
  - Consider the new ordinance requires underground wiring and sidewalks
- Very low enrollment (40% from mainland) and scores are ranked very low in the 50s
- Alternatives are to keep the school, consolidate or have children educated withing Stafford Twp
